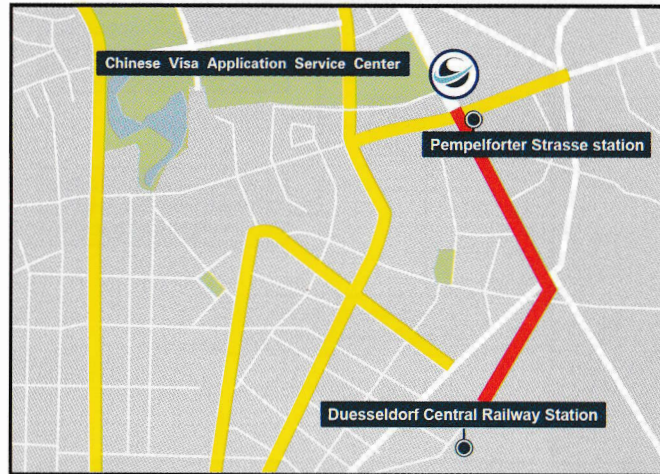

About us

The demand for Chinese visas has grown rapidly in recent years. To provide a better service for visa applicants, the Chinese Consulate General, following the success of the visa centers of other countries, decides to introduce the Chinese Visa Application Service Center (CVASC). CVASC is responsible for receiving visa applications of ordinary passport holders for visiting the Mainland of China, collecting visa fees on behalf of the Consulate General and returning processed visa applications.

Our Service

- Call center or e-mail reply of frequently asked questions regarding Chinese visa application
- Online filling out the visa application form
- Online booking for application submission
- Extended office hours for submitting application and on site queuing system
- Payment by debit card, or in cash

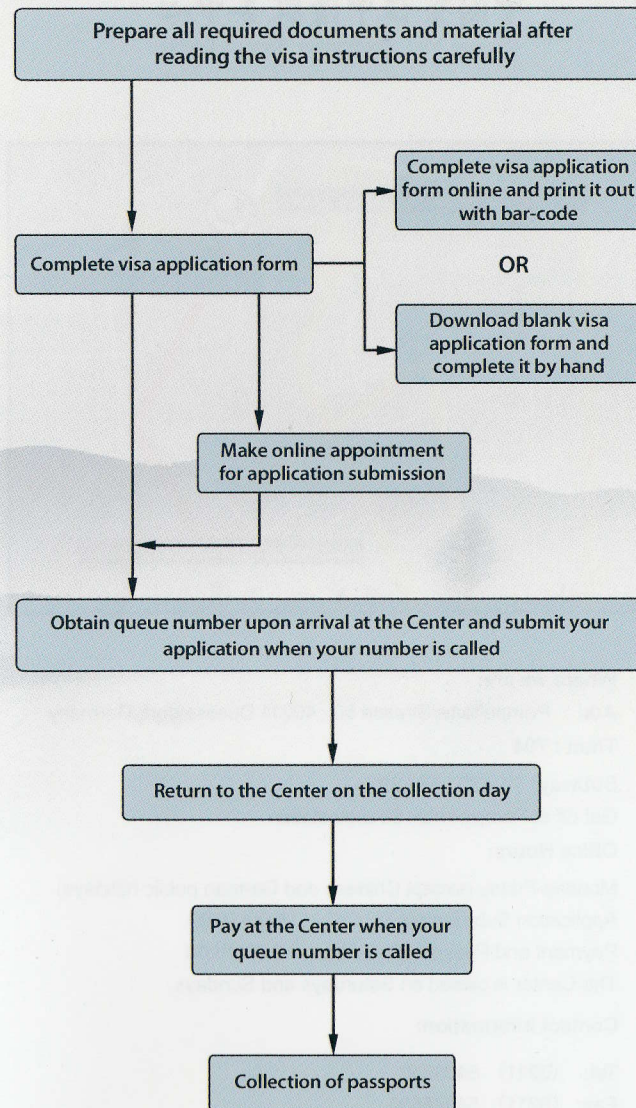
Advantages of using CVASC

Important Notes

The Center has no involvement in the visa assessment and decision-making process. Whether a visa to be issued or not, and what type of visa to be issued as well as its period of validity, number of entry and duration of stay shall be decided by the Chinese Consulate General in the light of China's relevant laws and regulations. The Chinese Consulate General has the right to request the applicant to provide additional supporting documents or to come to the Consulate General for an interview.

Application Procedures



Processing Time

Regular visa processing time is at least 5 working days.

Special note about postal application: The Chinese Visa Application Service Center Duesseldorf does not provide postal application service. By necessity, the Chinese Visa Application Service Center Frankfurt am Main is available for further information about postal application. The processing time for postal application is approximately 10 working days, if the applications meet all the visa requirements.
